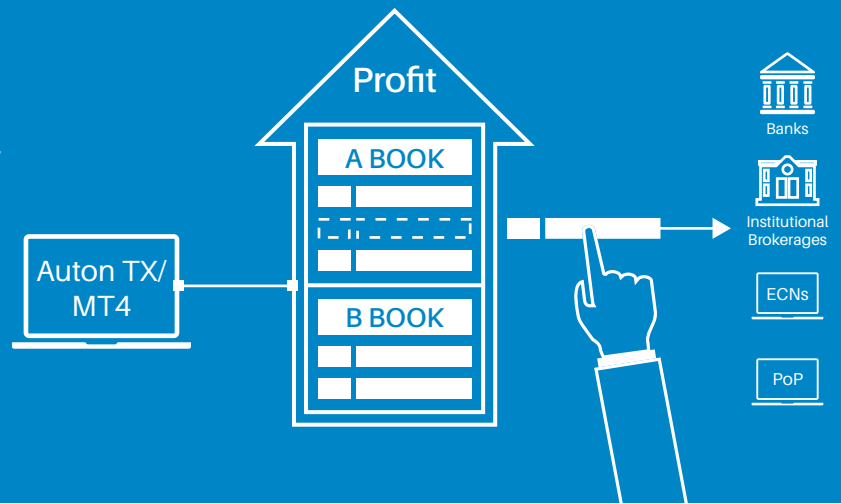

The most powerful A/B Book mixed trading solutions, fully covering all the functions that traditional market makers (B Book) and STP brokers (A Book) need. TX-Hybrid helps you to gain total control over your risk exposure no matter you are dealing with scalper or market fluctuation.

### Position Management

By using our advanced routing rules, all orders can be defined to route by per group, per product routing, or by portion. Complementing by our override mechanism, an A Book client could be excluded from routing out to LP. Such flexibility gives you a higher controllability on every trade execution.

### Top Tier Inter-Bank Liquidity

By leveraging the ultra-low latency infrastructure and multi connections to top tier ECNs and liquidity providers, brokerages can benefit from the greatly reduced slippage on limit / stop order and cut position, effectively minimize the risk and maximize their profits by accessing inter-bank liquidity.

### Robust Pricing Engine

TX-Hybrid and TX-Bridge include robust built-in pricing engine, which supports multi-feed connection and integrates different feeds through sophisticated algorithm, helping to improve the pricing quality and avoid disconnection problem. The built-in filter and volatility mechanism can filter out spike price and invalid price smartly, or auto enlarge the spread on top of the market spread, instantly protecting a dealer from suffering a loss.

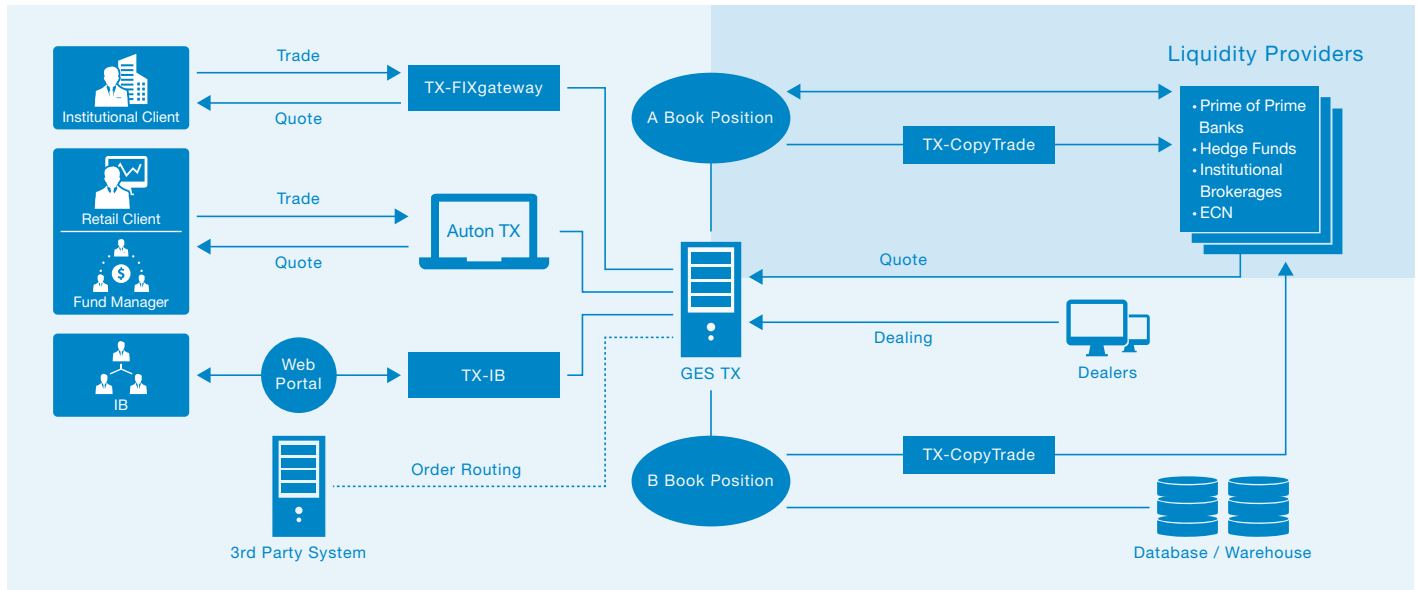
### Comprehensive Reports

## TX-Hybrid Trade Flow

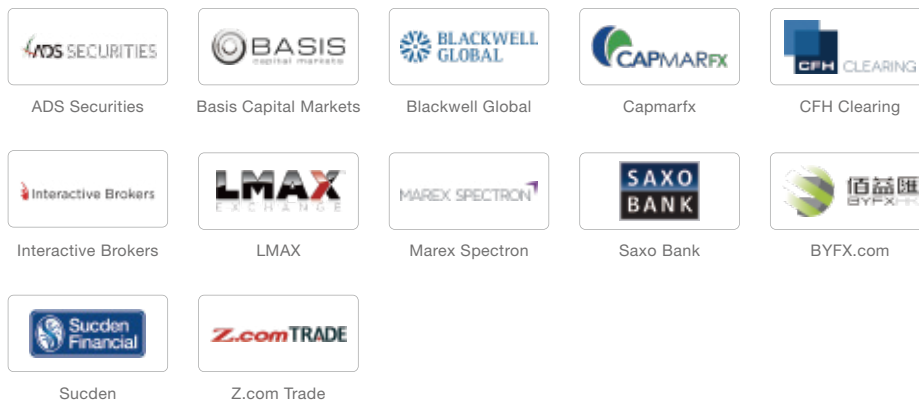
